Custodial Information

[Ohio Revised Code 3313.672(b)]

- B. Parents are divorced or legally separated; child resides with parent that has legal custody by court order. (If this is your situation, you must provide the school with a copy of the court order within 30 days)
- C. Parents are divorced or legally separated; child resides with parent that **DOES NOT** have legal custody. (If this is your situation, you will be asked to pay prevailing tuition rates of the district or obtain legal custody within 60 days.)
- D. Child lives with a Guardian who has been granted legal custody by court order. (If this is your situation, you must provide the school with a copy of the. court order.)
- E. Child lives with a Guardian who **HAS NOT** been granted legal custody by a court order.

 (If this is your situation, you will be asked to pay prevailing tuition rates of the district or obtain legal custody within 60 days)
- F. Child lives with Foster Parents.

 (If this is your situation, you must have a representative of the custodial agency with you and all necessary court orders, proof of district responsibility for educational costs and previous school records at the time of enrollment. Your child will not be enrolled without meeting all these requirements.)
- G. Child is 18 years of age or older and lives apart from his/her parent or guardian.
- H. Tuition Student.(You must obtain a tuition agreement with current rates and payment schedule from the Board Office)
