REQUIREMENTS TO CONTINUE IN CCP

- **Advise**

Attend CCP meeting with Mrs. Merickel

Request CCP courses on your Course Request Sheet - due 2/27

Submit Intent Form today or no later than 4/1

- **Qualify:** Returning CCP students may need to submit a transcript to Edison to qualify for courses
- **Register:** Complete and SIGN the Edison Registration Form with Mrs. Merickel to enroll in courses. Every student must complete a registration form, even for in-house CCP courses. Mrs. Merickel emails a copy of the registration form to the student (HHS email). Students may begin registering 4/1.

CCP DETAILS

- Ensure each of the CCP Admission Requirements is fulfilled. It is the **student's** responsibility to ensure that they have completed all steps to be registered for classes for the upcoming term. If in doubt, if the student does not have an email copy of a registration form, they are NOT registered for the upcoming term.
- Be aware that scheduling conflicts occur when working to make a course plan for a student if they opt to take courses outside the school building.
- Students may not exceed the equivalent of 30 semester hours per year between high school and CCP courses; exceeding 30 hours incurs cost and is more than most students can and should handle in an academic year.
- Must be a full-time student. Athletic eligibility must also be taken into consideration when scheduling.



CCP CAVEATS

- Courses are for both high school and college credit. Therefore, grades earned in CCP courses will be part of both the HS transcript/GPA/class rank AND the college transcript.
- The student/family is responsible for paying for all costs associated with the course, if the final grade is lower than a “D,” or if the student withdraws from the course past Edison’s drop deadline. This must be remitted in order to participate in graduation, receive a diploma, and have final transcripts released to colleges.
- If a student fails a course, or their college GPA hits below a 2.0 there is a probationary process that will affect the student’s ability to continue in CCP.
- The student/family is responsible for all transportation to/from Edison’s campus for any CCP courses taken there.
- The parental role changes if a student takes classes off-campus. Communication with Edison must be initiated by the student. There is no “ProgressBook” for parents to keep tabs on their student’s grades.



REVISED HANDBOOK POLICY: COURSE CHANGE/DROP

- Examples of why classes may not be changed/dropped include, but are not limited to:
 - A student wants to be in class with another student
 - A student has a personality conflict with the teacher or instructor
 - A student has poor grades in a class or with a certain teacher
 - A student is not earning the grade they desire in the class
- Students taking CCP courses are also highly encouraged to make carefully informed decisions when scheduling classes. If a student wishes to drop a class at any time, the school counselor must approve the withdrawal. Withdrawals after 10 days from the start of the course term will not be granted unless it is determined that an extenuating circumstance necessitates the withdrawal. Any extenuating circumstances for dropping a course must be reviewed and approved by the principal.



COLLEGE PREPARATION

- University admissions officers look most favorably at students who exhaust their high school's available curriculum. Classes that meet daily are undoubtedly the best preparation for the academic rigors of education beyond high school.
- University admissions officers and scholarship committees seek well-rounded students who take enriching elective coursework and that are also a part of school-based groups and activities.
- Therefore, you will be encouraged to maximize your college-prep experience by taking all the classes at HHS that you can that will enrich your academic profile, CCP or not.
- Being “college ready” is not just academic. Consider time-management and organizational skills. Consider emotional and social transitions & mature content.

CCP IS GREAT, BUT...

- We are seeing an increase in the number of students struggling and sometimes not passing online courses, some of these in classes required for graduation. Carefully consider the choice to take an online class, especially when the class is offered at HHS by our teachers at a high school pace; our current success rate for in-house CCP is 100%.
- If a student is thinking of taking a course offered at HHS at Edison instead, carefully weigh the pros and cons. The question is...why? Does the answer to that question line up with the student's future goals? Does an online class provide the same immersion in the curriculum, instructor interaction, and support that you expect from the classes your student is taking at HHS?
- CCP credits are not a guarantee; some colleges and college majors accept few or zero CCP credits. This is especially true in engineering and technical fields. Be aware that your curriculum choices should support your long-term goals.




HOW TO ACCESS HELP
